


TERMS OF SETTLEMENT

Parties in this suit have agreed to settle this matter amicably and same was perfected base on the following conditions.


1. That the Defendant has agreed that he is owing the claimant the sum of one hundred and eighteen thousand (N80,000.00) Naira Only
