


**JUDGEMENT**

TERMS OF SETTLEMENT

1. AGREED TERMS

- 1.2. Subject to receipt of the payment stipulated in Clause 1.1 above, Barrister Adams Idris agrees to relinquish all prior claims of interest, damages of any kind, and legal fees arising from the contractual relationship between the Parties.
- 1.3. The provisions outlined in Clauses 1.1 and 1.2 will represent a full and final resolution of any dispute relating to Suit No: SCC/134/03/2024.
- 1.4. Notwithstanding the foregoing, nothing in this Agreement shall preclude either Party from pursuing a new claim or continuing an existing claim should there be a default on the obligations set out in this Agreement.
- 1.5. Upon NIRSAL's satisfaction of its obligations under this Settlement Agreement, Barrister Adams Idris shall withdraw any ongoing action, whether before a court

or tribunal, seeking any entitlements relating to the subject matter of this Agreement.

- 1.6. Each Party shall bear its own costs, including legal fees and any other expenses incurred in executing this Agreement.
- 1.7. Subject to the Court's acceptance of this terms of settlement, this Agreement shall be recorded as the Consent Judgment of this Honourable Court in these Proceedings.


## 2. AUTHORITY TO SIGN

2.1. Each Party represents and warrants to the other Party that:


- (a) It has the full legal capacity and authority to enter into and perform its obligations under this Agreement.

The Parties have signed this Agreement on the 26<sup>th</sup> day of January 2024.


