


**JUDGEMENT**

TERMS OF SETTLEMENT

The complainant has via this court's Notice of demand, Summons and Complaint dated the 12<sup>th</sup> day of January, 2023, is seeking for the following reliefs against the Defendant:

- a. This Honourable Court is urged to take the cognizance of the credit facility granted to the Defendant by the Complainant in the total sum of ₦2, 070, 000 (Two Million Seventy Thousand Naira) only, and has paid the equity of the sum of ₦624, 200.00 (Six Hundred Twenty Four Thousand Two Hundred Naira) only, leaving the balance of the sum of ₦1, 445,800 (One Million Four Hundred and Forty Five Thousand Eight Hundred Naira) Only. Which the Defendant failed to refund as at when due and or agreed upon.
- b. An Order directing the Defendant to pay the loan balance of the above money in the sum of ₦1, 445, 800 (One Million Four Hundred and Forty Five Thousand Eight Hundred Naira) Only, being the amount of dept offered to the Defendant which he failed to refund as at when due and or agreed upon.
- c. An order directing the Defendant to pay the sum of ₦200, 000.00 (Two Hundred Thousand Naira) only as cost of prosecution of this case.

WHEREUPON, the parties on their free volition agreed to settle the matter on the following terms;

1. That the Defendant has admitted the entire claims of the Complainant, to the effect that; sometimes in the year 2023, the Defendant was in received of credit facility granted to him by the Complainant in the sum of ₦2,070, 000 and paid the equity of the sum of ₦624, 200.00 leaving the balance of the sum of ₦1,445,800.
2. That the Defendant agreed to pay to the Complainant the sum of ₦100, 000, (One Hundred Thousand Naira), only as cost of prosecution of this case.
3. That the Defendant undertake to be paying the complainant the total sum of not less than ₦50, 000,(Fifty Thousand Naira) only, out of the total loan, monthly from his salary before he settle the entire sum of the loan balance.
4. That the Defendant undertake to settled the entire loan balance in the sum of ₦1, 445, 800 (One Million Four Hundred and Forty Five Thousand Eight Hundred Naira) Only, and the cost of ₦100, 000, (One Hundred Thousand Naira) only, on or before the end March, 2024.
5. That the parties in this suit agreed to be bound by these terms and urge this Honourable Court to accept it as a consent judgment of the court.
