


Upon further confirmation from the defendant, he told the court that the terms of settlement filled represent their agreement reached.

TERMS OF SETTLEMENT

The Claimant via a specially endorsed writ of summons, seeking the reliefs contained on the face of the writ against the Defendant.

Upon serving the Defendants with the Claimant's writ and Demand, the parties decided to opt for an out-of-court settlement, in an attempt to settle their differences off litigation amicably.

WHEREUPON, the parties out of their own free volition agreed to settle the matter on the following terms:

1. It is the agreement of the parties that the Defendants shall pay unto the Claimant the sum of **Six Hundred Thousand Naira (N 600, 000) Only**, being the outstanding indebtedness, the Defendants owe the Claimant.
2. The parties agreed that Defendants shall make payment of the amount stated in the preceding paragraph in Six (6) installments: the first installment on 16th November 2024 of the sum of **N100,000**; and the same amount shall continue to be paid every month up to the final installment on 16th April 2025.
3. The parties have unanimously agreed that the above agreement shall be complied with strictly and that there shall be no future suit on this issue, except in breach of any of the terms stated herein.
4. This agreement is essentially done to sustain the cordial relationship existing between the parties, saving the parties the trauma of litigation,

and waste of valuable time and resources that would have been channeled for other essential purposes.

5. All parties herein agreed to be bound by these terms and urge this Honourable Court to accept it as a consent judgment in this matter.
