

JUDGEMENT


This case brought pursuant to small claims court practice direction NO 2 of 2022, the claimant has filled and filed small claims Court forms SCA 2 & SCA 3 dated 4TH day of July, 2024, defendant has been duly served with the process of this court as evident by affidavit of serviced dated 16/7/ 2024 deposed to by one Abdussalam Abdullahi a sheriff of this Court.

Before the commencement of hearing parties have amicably settled the matter out of court, consequent upon which they filed a terms of settlement dated 24th day of July, 2024 duly sign by the parties in presence of their witness , on the date fixed for adoption, learned counsel to the claimant apply for the clause NO 2 of the terms to be amended to the effect that payment for the loan be started from end of January 2025 instead of July 2024 which has not been objected and the court grant

the application, they adopted it and urged the court to consider same and enter consent Judgment as per the terms, thereafter the matter stood own for Judgment.

After hearing both parties and having gone through the content of the afore mentioned terms properly executed by the parties, I hereby enter judgment as per the terms of settlement dated 24th July, 2024 herein attached against the parties.
