
JUDGEMENT

TERMS OF SETTLEMENT

The claimant filed a suit against the defendant claiming the sum of ₦700,000 and N104,000 as cost of filing and prosecuting the matter.

The parties have agreed to settle the matter in the following terms:

- a. The defendant admitted the amount of ₦700,000 claimed by the claimant.
- b. The parties have agreed that the defendant will pay the sum of ₦70,000 as cost of filing and prosecuting the case.
- c. The defendant admitted to pay the total sum of ₦770,000 on or before 10th March 2025.
- d. Parties have agreed that in the event (c) above is not realized the defendant shall pay the sum of ₦200,000 on or before 10th March 2025 and the balance of ₦570,000 shall be paid by instalment by paying ₦100,000 at the end of each month starting by April 2025 until final liquidation.
- e. The parties have agreed that in the event the defendant failed to fulfill the terms herein stated the claimant shall made an application to the court for execution of judgment
- f. Party have agreed that the above terms shall be adopted as consent judgment of the court.
