


On the 11<sup>th</sup> day of March 2025 when the matter came up for report of settlement learned counsel inform the court that parties have settled and have equally filled

TERMS OF SETTLEMENT

2. That the Defendant has agreed to pay the Claimant the sum of **One Million, Five Hundred and Forty Thousand Naira (N1,540,000.00k)**.
3. That the Defendant has also agreed to pay the Claimant the sum of **Two Hundred and Fifty Thousand Naira (N250,000.00k)** only as the cost of filing this suit and engaging a lawyer.
4. That the Defendant has also requested the sum of **One Million Naira (N1,000,000.00k)** only from the Claimant in order to boost his business and also pay back what he owes the Claimant.
5. That the Claimant has agreed to the Defendant's request and has given him the sum of **One Million Naira (N1,000,000.00k)** only in order to boost his business and also pay back what he owes the Claimant.
6. That the total sum of money to be paid by the Defendant to the Claimant now is **Two million, Seven Hundred and Ninety Thousand Naira (N2,790,000.00k) only**.
7. That the Parties have agreed that the Defendant shall be making payments of monthly installments of the sum of **Four Hundred Thousand Naira**

**(N400,000.00k)** to the Claimant until the full and final payment of the entire sum of **Two Million, Seven Hundred and Ninety Thousand Naira (N2,790.000.00k) only.**




