JUDGEMENT




Upon confirmation from learned counsel to the defendant

TERMS OF SETTLEMENT


WHEREAS:

IT IS HEREBY AGREED AS FOLLOWS:


1. That defendant shall pay the sum of N 1,230, 000. 00 (One Million, Two Hundred and Thirty Thousand Naira) only to the Claimants for the money had and received for a business which has wholly failed.
2. That the defendant shall pay the Claimants above stated sum within two instalments as provided in paragraphs 3 and 4 below.
3. That the first payment of the sum of N615,000:00K (Six Hundred and Fifteen Thousand Naira only will be paid by the defendant on or before 24th March, 2025 and that the remaining outstanding balance of the sum of N615,000:00K (Six Hundred and Fifteen-Thousand Naira only will be paid on or before 30th June, 2025.
4. That upon the complete payment of the sum of N 1,230, 000. 00 (One Million, Two Hundred and Thirty Thousand Naira) only by the defendant to the claimants, this suit shall come to an end.
5. That all parties shall cease to make further claims.
6. The final satisfaction of the above stated terms shall abate hostilities and terminate the entire suit as the judgment of this Hon. court.
7. All parties to bear their respective cost.
