
CONSENT JUDGEMENT

TERMS OF SETTLEMENT

WHEREAS:


1. The Claimant herein has instituted this action before this Hon. Court claiming the sum of N280, 000 against the Defendant being his outstanding balance of his professional fee the Defendant owed him.
2. The Defendant has approached the Claimant for an out-of-court settlement with a view to agreeing on the modalities to settle the above stated sum of **N280, 000.00 (Two Hundred and Eighty Thousand Naira)** only, the amount not being denied by the Defendant

IT IS HEREBY AGREED AS FOLLOWS:


1. That the Defendant shall pay to the Claimant the sum of **N280, 000.00 (Two Hundred and Eighty Thousand Naira)** only, in 3 monthly instalments.
2. That the Defendant shall pay the sum of **N100, 000.00 (One Hundred Thousand Naira)** only, on or before the end of the month of September, 2025, and **N100, 000.00 (One Hundred Thousand Naira)** only, and finally the Defendant shall unfailingly pay the sum of **N80, 000.00 (Eighty Thousand Naira)** only being the final instalment payment on or before the end of the month of November, 2025 unfailingly.
3. That the Defendant shall be consistent in making the monthly payment and in the event of failure to comply the Claimant is at liberty to resort to this Hon. Court for execution.

4. That the Defendant is at liberty to pay more than the agreed monthly instalment of **₦100, 000.00 (One Hundred Thousand Naira)** only, if he has the wherewithal to do so, but not less than the amount.
5. That terms 1 – 4 above shall be pronounced as the consent judgement of this Hon. Court in this matter.
