DEFENDANT – that is the true position. We urge the court to adopt same as the judgment in this suit.


**TERMS OF SETTLEMENT**

TERMS OF SETTLEMENT

WHEREAS the Claimant instituted this action against the Defendant before this Honourable Court claiming the sum of ₦407,000 (Four hundred and seven thousand naira) being money owed and due to the Claimant for yoghurts supplied to the defendant.

AND WHEREUPON the parties have amicably resolved the dispute and agreed to settle same upon the following terms:

Payment of part Sum

1. The Defendant agrees to pay to the Claimant the sum of ₦107,000 (One hundred and seven thousand naira) on or before the 5<sup>th</sup> January, 2026.
2. Payment of the outstanding

Parties agreed that the outstanding sum of ₦300,000 (three-hundred thousand naira) will be paid by installments.

( The defendant shall pay ₦40,000 (forty-thousand naira) to the claimant on or before the last day of each month, commencing

from the 31<sup>st</sup> Day of January, 2026 until the outstanding sum is fully liquidated.

2. All parties herein agreed to be bound by the above terms and urge this Honorable Court to enter same as a consent judgment. Most obliged.


