- Thee sum of ₦1,590,000 (One Million Five Hundred Thousand Naira) only for the supply of yoghurt
- The sum of ₦20,000 (Twenty Thousand Naira) as cost of action

On the 20<sup>th</sup> day of October 2025 when the matter came up for hearing learned counsel to the defendant PATRICA JAMES ESQ inform the court that there is a move for settlement she humbly apply for a date to see the possible means of settling the matter out of court, upon confirmation from the counsel to the claimant J T KULEVE ESQ he told the court that is the true position.

On the 4<sup>th</sup> day of November 2025 learned counsel to both parties inform the court that they have settled amicably and have filled their terms of settlement dated 3<sup>rd</sup> day of November 2025 apply to adopt same as the consent judgment in this suit.

**COURT** – In view of the terms of settlement dated 3<sup>rd</sup> day of November 2025 reached between the two disputing parties (i.e. claimant and defendant) in the present of their respective counsels (attached herewith) in respect of this suit before the court, I hereby enter same as the consent judgment in this suit.

**RIGHT OF APPEAL** – There is a right of appeal to the Bauchi state high court of justice (small claims court) within 14 days from today.

TERMS OF SETTLEMENT

This Terms of Settlement is made on this 03 day of NOV, 2025, by and between:

1. The Claimant: Edey Fidelis Okwe and,
2. The Defendant: Joy Solomon Okoye

WHEREAS, the Claimant is owed a total sum of 1,590,000 (One Million, Five Hundred and Ninety Thousand Naira) by the Defendant; and the Defendant has agreed to repay the said sum under the terms agreed upon in this Agreement.

NOW THEREFORE, both parties agree as follows:

1. Total Amount Owed

The Defendant hereby acknowledges indebtedness to the Claimant in the total sum of 1,590,000 (One Million, Five Hundred and Ninety Thousand Naira).

2. Payment Terms

The Defendant agrees to repay the said sum in installments as follows:

I. An initial payment of 300,000 (Three Hundred Thousand Naira) shall be made on or before 30th November 2025.

II. Starting from January 2026, the Defendant shall pay 100,000 (One Hundred Thousand Naira) monthly until the entire outstanding debt is fully paid.

### 3. Method of Payment

All payments shall be made via bank transfer or any other method at the court's registry.

### 4. Default Clause.

In the event where the judgment debtor defaults in payment for one month the judgment creditor will enforce the judgment to recover the amount outstanding with a cost in the sum of #50,000. Claimant:






