

**JUDGEMENT**

This case was brought pursuant to the Bauchi-state-practice direction on small claim court no 2 of 2022 the claimant filled and filled form SCA 2 and 3 dated 22<sup>TH</sup> day of December, 2025. The defendant in this suit have been duly served with the originating process of the court as required by law as evidence by affidavit of service dated 22<sup>nd</sup> day of December, 2025 deposed to by the bailiff of this Honorable Court one ABDULSALAM ABDULLAHI.

I have considered all the processes filed and duly served with the letter of demand by way of substituted means by pasting same on 12<sup>th</sup> November, 2025.

The same letter of demand contained the sum of N72,925.00 only.




The fees paid for filling the suit on the 9<sup>th</sup> of October, 2025 also contained the sum of N72,925.00 only however, form SCA 3 that was signed contained the claim of N242,614, N2,500 as cost of filling and N30,000 as cost of this action.

Considering the origination process and fee paid for filling this matter is concerning the claim of N72,925.00 I also considered the testimony one in person of Garba Iliya all the exhibits tendered before this Honourable court.

This Honourable court entered a judgment in favour of the claimant as per the valid claim of the sum of N72,925 as the main claim. The defendant is also ordered to pay the sum of N2,500 as cost of filling and the sum of N30,000 as cost of this action.

By this judgment the defendant is hereby ordered to pay the total sum N105,425.00 only

There is right to appeal to the High Court of Justice Bauchi within 14 days as provided by the Practice Direction on Small Claims Court No2 of 2022 of Bauchi State, if the judgement debtor is aggrieved with this judgement.
