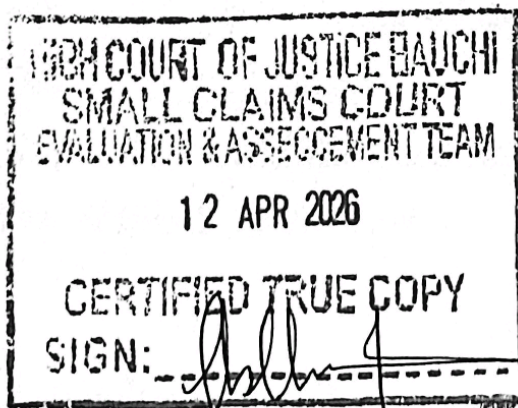
**CONSENT JUDGMENT**

Whereas By writ of summons Dated 10<sup>th</sup> February 2026 with Suit No. SCC/NNG/15/2025 Claimant Herein commenced Recovery of Debt proceedings Against The Defendant Herein.

**NOW IT IS HEREBY AGREED BY THE CLAIMANT AND THE**

**DEFENDANT IN THIS SUIT AS FOLLOWS:**

1. That the Defendant (Yusuf <sup>SHUMBU</sup> ~~SUCUBU~~) current indebtedness to the claimant as at the 10<sup>th</sup> day of February, stands at N280,000.00 (Two Hundred and Eighty Thousand Naira) Only.
2. That the above stated sum being outstanding Defendants indebtedness to the claimant would be paid uninterruptedly over the next two (2) corresponding last day of each month thereafter until the 31<sup>st</sup> day of each month respectively.
3. That the said sum shall be paid instaintally and consecutively

As follows:

- i. N100.000 (One Hundred Thousand Naira) shall be paid on or before the 11<sup>th</sup> Day of February, 2026. ✓
- ii. N90, 000 ( Ninety Thousand Naira ) Shall be paid on or before the 22<sup>nd</sup> Day of February , 2026. ✓
- iii. N90, 000 ( Ninety Thousand Naira ) Shall be paid on or before the 3<sup>rd</sup> Day of March , 2026.


- iv. That the cost of this action in the sum of N10,000 (Ten Thousand Naira) Only, shall be paid on the 3<sup>rd</sup> day of March, 2026.
- 4. That the above monthly sums, which would be paid over the next 2 (Two) month as reflected in paragraph 3 above. Shall be paid through the Registry of small claims court Ningi.
- 5. That this term of settlement is to be entered as the consent judgment of the Court.
