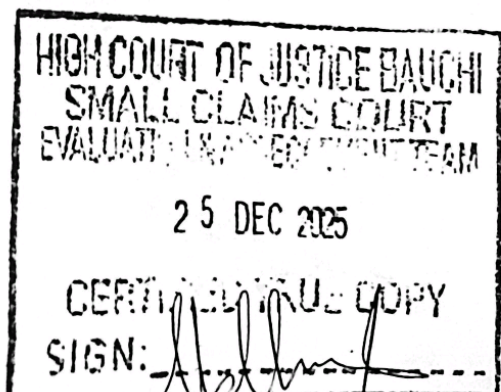
JUDGEMENT

The claimant has filled and filed small claims forms SCA 2 & SCA 3 dated the 19/12/2025, the defendant has been served with the process of this court as evident by affidavit of service dated 22/12/25 deposed to by one Abdullahi Ibrahim a bailiff of this Court.
