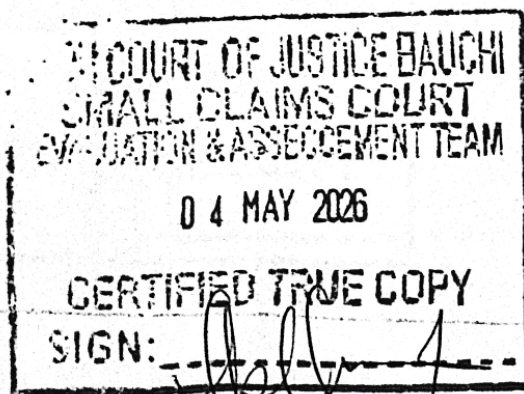

JUDGEMENT.

Claimants visa vis Barau Madaki and RIFAN Bauchi state chapter had approached this honorable court, with their complain / claim.

That the defendants: Audu Zakka, of Bogoro local government are indebted to the claimants an amount of money to the tune of (₦524,000.00) five Hundred and twentyfour Thousand Naira for over a period of time but refused to pay them back after several demands made to them.

Upon listening to the claimant's claim, and after all the necessary inquiry made by this honorable court.



The court has formed an opinion that the complainant's claim has dully satisfied the requirements as in article 2 (a, c & d) respectively of districts courts law practice directions on small claims.

In compliance with the rules guiding the practice directions on small claims, form SCA1 that is letter of demand was filled and served on the defendant, so also form SCA2 was similarly filled, thereafter form SCA3 that is small claims summon was equally filled and served on the defendant on the 14<sup>th</sup> day of February 2026.

The sheriff of this honorable court had in compliance with article 5(2) SCC practice direction filled and filed form SCA6.

On the day fixed for hearing of the matter, both claimants and defendants appeared before the court and without legal representation.

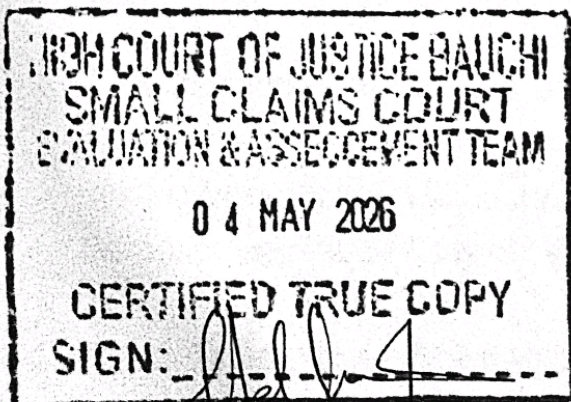
Having the matter mentioned, defendants had without any hesitation admitted the claimant's claim as contained in the demand letter served on him.

Following the admission made by the defendant of the claimant's claim, Terms of settlement dully signed by the claimants and the defendants, was filed and presented to the court.

However, this honorable court having been convinced with the party's terms of settlement dully signed by them which is dated the 8<sup>th</sup> Day of April 2026 is hereby accepted and same adopted as consent judgment of this honorable court in accordance with the article 9 (2) of the District Court's law practice direction on small claims court.

Cost of Twenty Thousand Naira (N20,000) is hereby awarded to the claimant as cost of prosecuting this case.

TERMS OF SETTLEMENT AS THE BASIS FOR CONSENT JUDGMENT.

Whereas By Writ Of Summons Dated 22/01/2026 With Suit No. SCCTBI/07CV/2026; Claimant(s) herein commenced recovery of debt proceedings against the Defendant(s) before this Honourable Court.

NOW IT IS HEREBY AGREED BY THE CLAIMANT(S) AND THE DEFENDANT(S) IN THIS SUIT AS FOLLOWS:

1. That the Defendant(s) (AUDU ZAKKA & 5 ORS) current indebtedness to the Claimant(s) as at the 22/01/2026 stands at N 524,000 (FIVE HUNDRES AND TWENTY FOUR THOUSANDS.....) only.
2. That after discussion for settlement of the matter, both the Claimant(s) and the Defendant(s) agreed that the Defendant(s) shall pay the total sum of N 524,000 (FIVE HUNDRES AND TWENTY FOUR THOUSANDS.....) only as full and final settlement of his/her/their debts.
3. That the above stated sum being outstanding Defendant(s) indebtedness to the Claimant(s) would be paid uninterruptedly over the next 3 (THREE) Months starting from APRIL 7, 2026 and the corresponding last day of each month thereafter until the 31<sup>st</sup> day of each month respectively.
4. That the said sum shall be paid by instalments and consecutively as follows:
