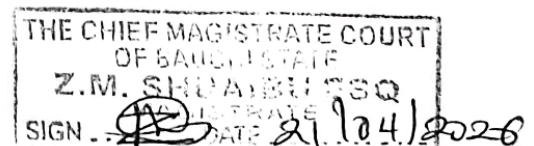
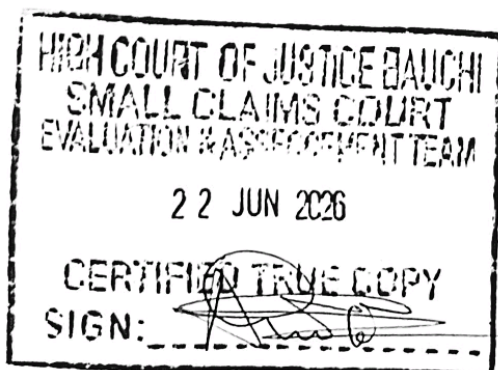

TERMS OF SETTLEMENT

WHEREAS: The Claimant took out a claim against the Defendant praying for the following reliefs:

- a. **AN ORDER** directing the Defendant to pay the sum of **Four Hundred and Fifty Thousand Naira Only (450,000)** to the Claimant being the principal sum of the money the Claimant lent to the Defendant
- b. **AN ORDER** directing the Defendant to pay the Claimant the sum of **One Hundred Naira Only (N100,000)** being the cost of action.

WHEREAS: The Defendant has approached the Claimant to settle this matter amicably out of Court and the Claimant accepted the offer made by the Defendant to settle the matter out of Court.

NOW IT IS AGREED AS FOLLOWS:


- 1. That the parties have agreed that the total sum of money the Defendant shall pay to the Claimant is the sum of **Three Hundred and Ninety Thousand Naira Only (N390,000.00)** as full and final settlement of the Defendant indebtedness to the Claimant.
- 2. That the Defendant shall pay the sum of **N20,000** as cost of action.

3. That the Defendant shall commence payment by paying the sum of **One Hundred and Fifty Thousand Naira Only (150,000.00)** to the Claimant on the 14th of May, 2026.
4. That subsequently, the Defendant shall pay the balance of **Two Hundred and Sixty Thousand Naira Only (N260,000.00)** to the Claimant in two instalments in the order of **One Hundred and Thirty Thousand only (N130,000.00)** on the 14th of June, 2026 and 14th of July, 2026.
5. That the said payments shall be made to the Claimant through is counsel vide account number **0025845594** Access bank bearing Muhammad Mukhtar Ibrahim.
6. That the parties have agreed that these terms of settlement shall be adopted as the Judgment of this Court.
7. That this term of settlement shall be signed by the Claimant and the Defendant and the counsel in this matter.


