CONSENT JUDGMENT/ORDER

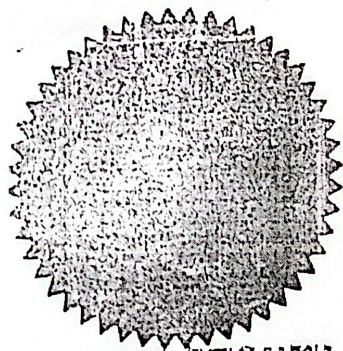

ORDER OF COURT

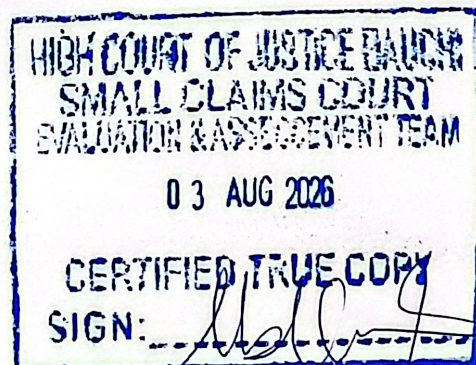
IT IS HEREBY ORDERED AS FOLLOWS:

TERMS OF SETTLEMENT AS BASIS FOR CONSENT JUDGMENT

Whereas By Writ Of Summons Dated 12th February 2026 With Suit No. SCCTB/16CV/2026, Claimant Herein Commenced Recovery Of Debt Proceedings Against The Defendants.

NOW IT IS HEREBY AGREED BY THE CLAIMANT AND THE DEFENDANT IN THIS SUIT AS FOLLOWS:

7. That the Defendants (LUKMAN SA'IDU & 1 ANOTHER) current indebtedness to the Claimant as at the 12th day of February 2026, stands at **N120,163.00 (One Hundred And Twenty Thousand Naira One Hundred And Twenty Naira)** only.
8. That after discussion for settlement of the matter, both the Claimant and the Defendants agreed that the Defendants will pay the total sum of **N90,163 (Ninety Thousand One Hundred And Sixty Three Naira)** only as full and final settlement of their debts.
9. That the above stated sum being outstanding Defendants indebtedness to the Claimant would be paid uninterruptedly over the next 3 (Three) months starting from March 1st 2026, and the corresponding last day of each month thereafter until the 31st day of each month respectively.
10. That the said sum shall be paid by instalment as follows:
