


TERMS OF SETTLEMENT

Parties in this matter herein agreed to settle this matter on the following terms

- a. Parties agreed that the defendant shall pay the plaintiff the sum of One Hundred and Fifty Thousand Naira only as first payment of the total sum of Six Hundred Thousand Naira Only on or before 30th November, 2023
- b. Parties also agreed that the defendant shall be paying the plaintiff the sum of Fifty Thousand Naira every ending of the month commencing from 31st December after the payment of One Hundred and Fifty Thousand Naira in the month of November, 2023 as stated in paragraph (a) above until the total sum of Six Hundred Thousand Naira is paid completely.
- c. That this term of agreement is made this 25th day of October, 2023.
